### **The real and actual path of the INSERTO PROJECT:**

Once the foreign citizen in possession of the necessary requirements, choose to access the INSERTO project, he will come into contact with a group of professionals of the project consists of: Social Worker, an Operator of the Centro per l'impiego and a Cultural Linguistic Mediator.

- The group shares the social and personal information of the foreign citizen and his current and previous work path;
- the group defines a project of start /restart to work;
- the group monitors the start / restart project at work and checks the results.

**HOW DOES IT WORK:** to be placed successfully in the INSERTO, the foreign citizen must formally allow that the different Offices and Professionals (such as Social Services, Centro per l'Impiego, the Cultural Linguistic Mediator) to share the information on his behalf, in order to build the path of shared help
